1. Information for each animal must be listed above.
2. A DNA sample of 25-30 hairs (including follicle/root) must be submitted for each individual animal listed above.
3. Hair sample should be sealed in a plastic Ziploc bag with name of exhibitor, name of specie, and all individual animal identification written on outside of Ziploc bag in permanent marker.
4. Immediate family members (brothers & sisters living at the same address) may enter lambs as a family. Please list all exhibitor information on the above form.
5. DNA samples and payment should be mailed in an 8 1/2 x 11 envelope to MLE Sheep PO Box 189 Union City, MI 49094.
6. This form, the Michigan Bred Certification forms and DNA samples must be postmarked by May 15. **NO EXCEPTIONS**
7. Envelopes **MUST BE CLEARLY MARKED MLE SHEEP**. You must include the \$15.00 per head DNA Submission fee with the DNA sample, You must also include the \$15.00 exhibitor fee, and the \$25.00/pen pen fee with this form.
8. **Each specie must be submitted in separate envelopes.**
